Stream Team Update

Last month the Board approved using up to \$1000 from Memorial Funds for a camera and other ancillaries needed to expand our system for outdoor worship. Before the day was out, Katie Baird told me that she would donate that amount, herself, so we did not have to use any Memorial Funds at all.

We purchased a fine, versatile camera (if anyone wants to check out the specs, it's a Canon Vixia HF R800) with an incredible lens with a true 32:1 optical zoom. It provides full-frame, high resolution video for streaming, but can also record digital, high-quality video and audio up to two hours at a time, and, if that isn't enough, can take high-quality photos.

Without getting too far into the weeds, we also purchased a capture card that turns the HDMI video from the camera into a quality USB signal that the computer can use, and well over 200 feet of various high quality, durable speaker, video, and other cables, and a fine professional camera tripod. We were blessed that the large tripod speakers needed for outdoor worship were previously donated to the church.

On May 2, for the first time, our outdoor worship experience was available four ways – live in person in the church yard, as well as live in person to cars in the parking lot on 105.5 FM, YouTube live at home, and recorded on You Tube to watch any time later.

All the equipment can be used to provide live streaming once we are back inside the building, instead of just in front of it. But let's remember that church is not a building, but where God and people are, even if that's in a parking lot in rain or snow, or at home.

Many thanks go to our computer wizard Carol Magyarics, and to the entire Worship Team for helping to set up and remove all the equipment and furniture for outdoor worship.
