

# **THE MARY CANN, PERLEA CONVERSE, AND LUCIUS CONVERSE MEMORIAL SCHOLARSHIPS MANTUA CENTER CHRISTIAN CHURCH**

In 1976 and 1987, the family of Mary Cann made memorial contributions to the church. In 1987, the family of Lucius Converse made a similar contribution.

The church board, being of the opinion that such memorial gifts should be used for something lasting, and realizing that money spent for education is a permanent and growing investment, voted to establish an annual scholarship award program.

In 1995, the family of Perlea Converse made a contribution to enhance the scholarship fund.

## **ELIGIBILITY**

To be eligible for consideration for these awards, it is only necessary that

1. A person be a member of the Mantua Center Christian Church (member of MCCC for scholarship purposes is defined as: one who has been baptized at MCCC or has officially transferred his or her membership to MCCC) and
2. Be admitted to any accredited college, university or technical or trade school offering post-secondary education or training. Each applicant will also be asked to complete an application form. There are no other eligibility requirements.

## **CRITERIA FOR CONSIDERATION**

Each applicant will be considered on the basis of these criteria:

1. The applicant's financial needs
2. The applicant's participation in the church
3. The applicant's potential for achievement in the selected educational program

It should be noted that these scholarships are not to be considered as a reward or payment for service to the church; nor can it be earned deliberately by extra service. Rather, it is our congregation's way of showing that we, as a people, care sufficiently about the future of our members that we want to insure that future in some small way. Questions about an applicant's involvement in our congregation are included, not as a basis of determining merit, but as an indication of a genuine tie and commitment to the church. The applicant's need and potential are more important criteria for awarding this scholarship.

## **AMOUNT OF THE AWARD**

Subject to change by Board action, the amount of each scholarship will be the annual interest payable on the initial investment in each scholarship fund. The scholarships will be issued in checks payable to the recipients or to the persons responsible for financing the recipients' education.

The scholarships are not automatically renewed, but a recipient may reapply each year if he or she is still eligible. One person may receive the award more than once, but it should be understood that if a previous recipient and another applicant who has never received the award are both under consideration and are equal in all other aspects, the award will be granted to the applicant who has never previously received it.

## **DATES**

Completed applications, with a letter or recommendation from a teacher, counselor, instructor, or professor should be given to a Scholarship Committee member by August 30. All applications will be reviewed in September, and the committee will present their selections to Outreach Ministry. All applicants will be notified in writing from the Scholarship Committee.

## **CONFIDENTIALITY**

All materials submitted by an applicant will be held in the strictest confidence. No one will read or see any of the applications or letters of recommendation except the three members of the Scholarship review committee. In the events that a Board member or another applicant questions the reviewer's selection, the applicant's permission will be secured before any information is released.
